The CFO Forum at the University of Washington Business School promotes communication between CFOs of leading corporations and UW faculty. Fusing academia with industry, the program promotes discussion and research on current topics of concern to CFOs. The Forum provides a means for CFOs to share their knowledge, and learn about the latest finance research.

The unique focus of this forum on research and knowledge dissemination differentiates it from other finance related organizations. CFOs gain access to input from faculty and other CFOs on key issues. Faculty learn the inside perspective on the financial issues currently arising in the business world, which helps to better focus future research.

The need for research and knowledge dissemination is especially important given the rapid changes in areas affecting CFOs.

to generate research, which in turn will affect future practice. Member firms and Business School students are the first beneficiaries as faculty research enters into practice and into the classroom.

The CFO Forum contributes to the educational mission of the Business School. CFOs in the Forum provide input regarding program and curriculum offerings that they believe would enhance the educational experience of the students. Students study current topics with practical relevance to the business community. Access to the CFOs, for example through speaker series and mentoring programs, gives students a better understanding of financial issues, and helps them prepare to undertake careers in finance.

The group assembles quarterly for Forum discussions on current topics. Recent topics include:

- How to Evaluate an Investment in Technology from a Financial Perspective
- When is Goodwill Impaired?
- Managing Expectations

The sessions promote interactive discussion and the exchange of knowledge among CFOs of leading corporations, Business School faculty, and local experts.
