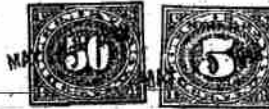

No. 1 RECORDED IN VOL. 25 OF PLATS PAGE 50, BEGINNING AT THE NORTHWEST CORNER OF SAID TRACT 113A AND RUNNING THENCE S 76° 23' 11" E ALONG THE NORTH LINE THEREOF 161.84 FT. THENCE S 58° 54' 43" E 40.82 FT. THENCE N 05° 17' 1" E 39.30 FT. TO A POINT 30 FT. SOUTHERLY FROM THE NORTH LINE OF SAID TRACT 113. THENCE S 88° 33' 03" E PARALLEL TO SAID NORTH LINE 113. 93 FT.
