Natural Resource Technician 2 (Non-Permanent)

The Department of Fish and Wildlife is recruiting to fill two (2) full-time, non-permanent, Natural Resource Technician 2 positions located in the Wildlife Program, Region 2; Wells Wildlife Area. The duty station is at the Wells Wildlife Area Complex, 54 Moe Rd. Brewster, WA; however, these positions will work throughout the region in and around Douglas and Okanogan Counties and may assist other Wildlife Areas located in Chelan County.

Under the direction of the Wells Wildlife Area Complex Manager and Assistant Manager, assist with land management activities on the Wells and Sagebrush Flat Wildlife Areas located in Douglas and Okanogan counties. The individuals in these positions perform a variety of technical duties related to land management and development, wildlife habitat restoration, pesticide laws and application, soil conservation, resource protection and the operation, maintenance and repair of equipment.

These are temporary positions with a period of employment from March 1 to November 30, 2014 based on program needs.

DUTIES:

- Implement existing programs to enhance wildlife habitat. Plant, fertilize and cultivate cover and feed crops. Follow a weekly schedule to irrigate food plots, shrub rows and cover crops using hand-lines, permanent sprinkler sets and center pivot systems. Plant, prune and trim trees and shrubs to provide better habitat. Assess field and vegetation conditions to determine timing of: pesticide applications, seeding and plant establishment, as well as equipment required for such activities. Spray pesticides on crops and weeds.
- Plants, fertilizes, and cultivates cover and feed crops; sprays crops, trees, and weeds; plants, prunes, and trims trees and shrubs to provide better habitat; applies herbicide for noxious weed control projects and other restoration activities.
- Drive 50hp–300hp tractors with attached implements to disk, cultivate, spray, mow, and harrow fields for establishment and maintenance of native habitat and food plots. Connect/disconnect hydraulic lines, category 2 and 3 hitches and 3-point hitches. Assess field and vegetation conditions to determine appropriate implement use. Adjust implements as needed to optimize effectiveness. Safely load, secure and transport tractors and implements using equipment trailers. Operates, cleans, greases, oils, services, and makes repairs to tools and equipment; makes emergency adjustments; Equipment includes tractors (and associated implements, disc, brush mowers, cultivation equipment, seeders, etc.), fork-lifts, dozers, back-hoes, atv/orv's, etc.
- Constructs fences; including barbed wire, split beam, chain link, etc.
- Monitors public use of the area; maintains good safety and public relations practices; provides department information; advises enforcement personnel of potentially illegal or disruptive actions.
- Performs sub-journey work in the construction and repair of buildings and other structures, roadways, pathways, fences, and related facilities on the site; estimates materials and time needed to complete the job.
- May act as a project coordinator on the site heading and training work crews in construction and maintenance projects and use of equipment; schedules, coordinates, and supervises the work of seasonal personnel when available.
- May supervise lower level staff.

QUALIFICATIONS:

Two years of natural resource management, habitat management, agriculture, and/or ranching experience.

Preferred Education/Experience

- Understanding of the following restoration and/or enhancement activities; shrub-steppe restoration/enhancement, riparian restoration/enhancement, food plot establishment, and operation and maintenance of irrigation systems.
- Knowledge of Region 2 Wildlife Area locations and access points.

Well qualified applicants will demonstrate competencies in the following areas:

- Safely operate small and large equipment including trucks, tractors, dozers, ATV's, and boats.
- Conduct fish and wildlife habitat development and maintenance activities including mowing, planting, seeding, fertilizing and irrigating.
- Safely operate hand and power tools and equipment.
- Safely use and store hazardous substances (e.g. pesticides)
- Repair barbed wire and deer fences including gates, H-braces and rock jacks.
- Use and maintain vehicles, equipment and tools including: hand tools, chainsaws, drills welders, grinders, saws, pumps, cranes, manual and portable chain hoists, sprayers, mowers, weed eaters, pickup trucks, pull and maneuver trailers, ATV's, heavy equipment, and snow removal equipment.
- Ability to work independently and safely in remote locations
- Effectively and safely operate and perform basic maintenance on farm machinery, ATV's, standard highway vehicles, boats, boat trailers and power and hand tools.
