The Department of Fish and Wildlife is recruiting one (1) full time, non-permanent, Natural Resource Worker 2 located in the Wildlife Program, Region 1, District 3. The duty station for this position is located in the *Clarkston Office with work performed throughout Asotin and Garfield Counties. *This position is anticipated to work from May through September based on program needs. *Correction.

This position under the direction of the Private Lands Biologist 2 will assist in the implementation of wildlife program goals and objectives to develop the Private Lands Program in Southeast Washington.

- Participate in the design, development and implementation of the hunter access program on private agricultural and private timbered lands in Southeast Washington.
- Provide public access opportunities on private lands for fish and wildlife related recreational opportunities.
- Works with private landowners to improve, protect, and restore habitat.
- Also will work with Conflict Specialist to prevent, reduce and control deer & elk damage on commercial crops.

DUTIES:

Primary duties include the following:

- Provide landowners with the materials necessary for the implementation of the hunter access program including signs and posting materials and assistance with posting of property boundaries.
- Conduct landowner interviews, write reports and assist with contract development regarding the WDFW hunter access program.
- Work with private landowners and coordinate with volunteers to manage the hunting access program on private timberlands and private agricultural lands in Southeast Washington.
- Provide direction and education to the public regarding hunter access opportunities on private lands.
- Direct and inform the public on local issues related to WDFW Wildlife Program function.
- Collaborate and work with Private land owners to prevent, reduce and/or control deer & elk damage on commercial crops.
- Assist with cross-program project implementation as necessary.

Graduation from high school or GED, including 1 year of high school science **and** 1 year of experience as a Natural Resource Technician 1 or 2 or Scientific Technician 1 or 2.

- Safely operate motor vehicles, ATV's and other specialized equipment and power tools. Transports supplies and equipment using trailers to remote sites.
