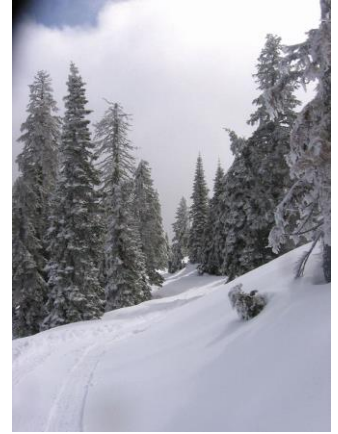
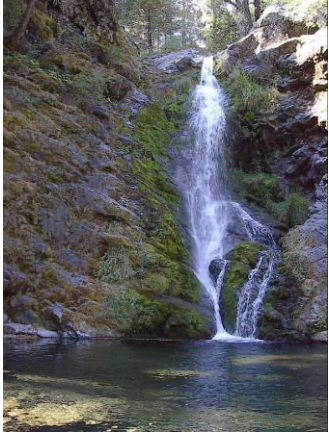

DESCRIPTION OF THE DUTIES ASSOCIATED WITH THIS POSITION:

This position is located on a Forest Service unit where the incumbent serves as a member of the Grindstone District Planning Team as a Silviculturist. The position has primary responsibility for the development, planning and application of silvicultural methods and practices. Provides advice and technical support and evaluation of proposed and on-going timber sale programs. Reviews and approves project plans. Makes on-the-ground examinations and analysis of forest areas. Plans, coordinates, and evaluates the timber stand improvement program. Inspects all phases of reforestation and stand improvement projects. Participates in preparation of and review of environmental analysis reports and environmental impact statements. Reviews Silviculture prescriptions to ensure they meet long-range land management plans. Coordinates with other resource specialists and serves as liaison with Federal, State, local, private organizations on reforestation concerns. Plans, coordinates, and conducts training on Silviculture principles and practices. Supervises less than 25%.

**Note: This position serves as a silviculturist. Incumbent must be a certified silviculturist upon placement in this position OR attain certification with three years of that date.**
