The Stanislaus National Forest is seeking candidates to join our team. This opportunity is a **TERM position** as a **Biological Science Technician (Wildlife), GS-0404-07**.

Duties; Works as a Crew Leader. Independently plans and conducts a variety of field studies of sensitive wildlife species to determine numbers, environmental conditions, and the condition of the species and its habitat, and factor affecting the health and welfare of the species and its habitat. Data elements collected include, but are not limited to such things as habitat conditions, age of habitat, location of species, nesting status, and the condition of the species being studied. Evaluate data and make recommendations for improvement of habitat or species. Data is collected in field locations. Develops work plans to collect required data, determines recording requirements, and factors to use for complete habitat and species condition analyses. Participates with RIM biologists in planning work.

The District ranges in elevation from 1,200 to 7,500 feet, with Mi Wuk Village at 4,500 feet. The annual program of work includes timber sales, reforestation and prescribed fire projects. All of the communities along the Highway 108 corridor have housing opportunities.

The Forest Supervisor's Office is located in Sonora, California about 45 miles east of Modesto. The cities of Merced, Stockton, Sacramento and San Francisco are located approximately 1 to 2 hours away. The four Ranger Districts, Mi-Wok, Calaveras, Summit and Groveland, are within 45 minutes of the Supervisor's Office.
