#### ABOUT THIS POSITION

The Lassen National Forest is seeking to fill a permanent full time position of Heritage Program Manager (GS-0193-12). The Heritage Program Manager is responsible for managing the forest heritage program, including: developing budgets; maintaining partnerships with individuals and organizations, including tribes; ensuring Forest compliance with the Regional Programmatic Agreement and other policies and regulations; maintaining existing grants and agreements for heritage work and developing new ones; and maintaining appropriate heritage data bases. Other duties include:

Responsibility for planning, directing, implementing, and administering a diverse and highly complex Forest's Heritage Resources Management Program, including the formulation of short and long term plans, policies and program guidelines in order to achieve Forest, regional and national goals and objectives.

Reviews and analyzes heritage resource laws, regulations and policies for effects on forest management programs and consistency with regional and national objectives. Recommends corrective actions to the Forest Supervisor or regional office when violations are found, and coordinates all necessary remedial action to obtain compliance.

Consults and coordinates with Indian Tribes under provisions of the National Historic Preservation Act (NHPA), Native American Graves Protection and Repatriation (NAGPA) and Forest/Tribal MOU's.

Has final review, authority and responsibility over all work, reports, recommendations and evaluations made by subordinate staff and district archeologists. Works with special interest groups and local organizations in

informing the public about the Forest's cultural resources and in developing interpretive programs and information for interested publics.

The duty station for this position is the Lassen National Forest Supervisor's Office in Susanville, California.

**About the Lassen NF:**

The Lassen is a total of 1.2 million acres or 1,875 square miles. It lies within seven counties; Lassen, Shasta, Tehama, Butte, Plumas, Siskiyou, and Modoc of Northern California, at the Crossroads, heart of one of the most fascinating areas of California. Here the granite of the Sierra Nevada, the lava of the Cascades and the Modoc Plateau, and the sagebrush of the Great Basin meet and blend. It is an area of great variety, greeting visitors and residents alike with a wide array of recreational opportunities and adventures. Fishing, hunting, camping, hiking, bicycling, boating, snowmobiling, cross-country skiing, and just exploring and learning about nature are among the many popular pastimes. Management includes timber for homes, forage for livestock, alternative energy, water, minerals, and many other natural resources.

**About Susanville:**

Susanville is a small (17,000 residents) but full service community on Highway 36 in northern California. The largest community in north-eastern California, it offers a hospital, a number of independent school districts, churches representing most denominations, a local community college, and a strong sense of community. The city of Reno, Nevada is 80 miles to the south, and both Chico and Redding, sizeable central valley communities, are within two hours drive. Real estate values vary greatly, with prices for a single family house currently ranging from \$175,000 - \$300,000 plus. Rentals are available and range from approximately \$500.00 plus per month.
