RE: UW Bothell Education Program 2009-2010 Review

This memorandum outlines the recommendations from the review of the Education Program at the UW Bothell. The Education Program offers an undergraduate Education minor, a Fifth Year Teacher Certification Program, a Professional Certification Program (ProCert), and the Master of Education degree with multiple program options. Detailed comments on the program can be found in the documents that were a part of the following formal review proceedings.

A subcommittee of the Graduate School Council presented the following findings and recommendations to the full Council at its meeting on January 6, 2011.

# **Program Strengths**

- The program strengths are numerous and well documented. High student satisfaction in the classroom and in community placements tops the list.
- Students reported high quality teaching that modeled the expectations for their teaching.
- The unit is strongly committed to tracking and assessing post-graduate outcomes and is already in the process of implementing some new measures recommended by the review committee. This will assist in their continued state accreditation and their ability to respond to needs in education.
- The program is characterized by strong leadership, a capable and valued staff, and a productive faculty.
- It is strongly committed to diversity as evidenced by their Dream Project (which partners UW Bothell students with first-generation and low-income high school students to help them achieve the dream of attending college) and is developing additional ways to recruit and retain underrepresented students.

## Challenges and Risks

- The main challenges of the program are quite simply growing pains. After a period of rapid growth the program may need to "rest" and stabilize many aspects of the organization.
- Efficiency of administrative functions, streamlining of curriculum, and consolidation of classes may be necessary due to years of "adding on" features to the program.
- The review committee was concerned that too much growth could compromise connections and positive relationships with community partners.
- Finally, the faculty, especially junior faculty, may be stretched too thin by the recent expansions and that their scholarship could suffer as a result.
- The committee was concerned that partner schools for student teaching are expecting
  more from universities and that care needed to be taken to ensure that course
  requirements were balanced with the demands of the short time students have in the
  classroom.

### Areas of Concurrence

- The Education Program concurred highly with the review committee findings and recommendations.
- It has begun implementing recommended changes, such as forming a standing committee to streamline curriculum and simplify an overly complex structure.
- In addition to the curriculum analysis, the unit is changing the structure and concepts
  of the student-teaching experience, improving program assessment, developing more
  written policies, and strengthening their use of technology to expand their reach and
  impact.

### **Graduate School Recommendations**

The Graduate School Council concurred with the review team's unanimous recommendation that all programs retain their continuing status, with the next review to occur in ten years (2019-2020 academic year).

We concur with the Council's comments and recommendations.
