## **Academy of Clinical Laboratory Physicians and Scientists**

The Academy of Clinical Laboratory Physicians and Scientists was organized on November 12, 1966, in Bethesda, Maryland. The Society holds an annual general membership meeting.

According to Article IV of the organization's Constitution, "Members of the Society shall be physicians, scientists and educators, primarily engaged in teaching, research and service in academic laboratory medicine." Membership is not limited to pathologists but is open to other physicians and scientists engaged in clinical laboratory work and to educators both in medicine and medical technology.

Many of the members of ACLPS are also members of other organizations for pathologists, other physicians and scientists. The Society was formed in response to a conviction among the founding members, that no national organization of physicians and scientists existed which could speak forthrightly and authoritatively about the needs and future developments in laboratory medicine in medical schools and other educational institutions.

The objectives of the Academy of Clinical Laboratory Physicians and Scientists are stated in Article III of the Constitution:

1. To encourage and advance the highest standards of education in laboratory medicine in medical schools and related curricula.
2. To encourage and promote the highest standards of resident training and postgraduate education of physicians and scientists in clinical pathology at universities and medical schools.
3. To encourage and promote the highest standards of service, education and research in academic laboratory medicine.

Requirements for membership are described in Section 3.1 of the Bylaws: "Candidates for membership shall be nominated by two members, who by means of sponsor form, shall adequately describe the qualifications of each candidate in terms of the aims and objectives of the Society. A curriculum vitae shall be a part of the application and it should include information concerning the candidate's dedication to and accomplishments toward the advancement of teaching and scholarship in laboratory medicine." Applicants must have attained at least the academic rank of Assistant Professor or its equivalent.
