Vice Chair of Laboratory Medicine and Medical Director, North Shore-Long Island Jewish Core Laboratories North Shore-Long Island Jewish Health System (NSLIJ)

The NSLIJ Health System Department of Pathology and Laboratory Medicine seeks a qualified M.D., or M.D., Ph.D. physician to serve as Vice Chair of Laboratory Medicine at two major tertiary hospitals in the system, North Shore University Hospital/Manhasset (NSUH; 812 beds) and Long Island Jewish Medical Center (LIJMC; 827 beds), and to be Medical Director of the "Core Laboratory" of this integrated clinical service line. The Core Laboratory serves as reference laboratory for the 14 acute-care facilities within the system, long term care facilities, and a broad client base of physician practice groups in Long Island. Annual operating revenues for the Core Laboratory exceed \$80M, based on a robust testing program in Anatomic Pathology, Laboratory Medicine, and Molecular diagnostics. This individual will provide highly visible and accessible leadership at both the tertiary hospitals, with oversight of clinical laboratory operations and accountability of those operations to senior executive hospital leadership. At the Core Laboratory, this individual will oversee both the Laboratory Medicine program and the outreach Anatomic Pathology service that operates through the Core Laboratory. In this capacity, s/he will act as a primary liaison between laboratory and executive management, referring clinicians, laboratory and administrative staff, marketing and client service. This will include developing positive relationships with hospital, laboratory, and outreach clients, and contributing to the overall strategic development of the laboratory product and outreach program. Responsibilities will also include ensuring compliance with regulatory requirements of CAP, CLIA, and the State of New York Department of Health; providing direction and leadership for the administrative and management of the Core Laboratories; and attention to compliance, utilization, and quality management programming. Strong leadership is also needed in all areas of Information Technology as it relates to the laboratories. This individual will be a faculty member of the Department of Pathology and Laboratory Medicine, an integrated department across the system, and will have academic rank in accordance with qualifications at the newly-forming Hofstra University School of Medicine. The individual will be expected to support the education of physicians-in-training at both the graduate and undergraduate level. Direct reporting will be to the Chair of the department and Senior Vice President of Laboratory Services. Required qualifications include board certification in Clinical Pathology (CP), with joint certification in Anatomic and Clinical Pathology (AP/CP) preferred; and substantive experience in leadership of a complex reference laboratory. The individual will be expected to have, or successfully obtain, a New York State license to practice medicine. An academic background with demonstrated academic accomplishments is desirable.
