United Indians of All Tribes Foundation Youth Home is searching for highly motivated individuals for their direct care Youth Advocate positions. There are presently full time positions and part time positions available for immediate hire. Working hours are 4p-midnight, midnight-8am and 8am-4pm. This is an excellent employment opportunity for college students and those wanting to start a career in social work or counseling fields.

ESSENTIAL FUNCTIONS:

- Provide supervision and direction to youth home residents.
- Assist caseworkers with case management duties
- Assure the safety of resident youth
- May assist in facilitating resident groups or activities as directed by the Youth Home Director.
- May prepare and serve meals in the absence of the Youth Home Cook.
- Ensure that resident rooms are neat and that chores are done.
- Maintain accurate and timely written documentation in resident files.
- Attend resident staffing and give input as needed.
- Perform specialized duties as defined by the Youth Home Director to be incorporated into the program service.
- Provide crisis intervention services as needed.

QUALIFICATIONS:

The minimum education requirements and qualifications for this position are:

- High School Diploma or GED.
- Some social services, human services, education or related work/volunteer experience.
