## NATURE OF ORGANIZATION

The only museum dedicated to contemporary art in our region, the Henry is internationally recognized for our groundbreaking exhibitions, for being on the edge of contemporary art and culture, and for being the first to premiere and sponsor new works by artists of note. ## **DUTIES AND RESPONSIBILITIES**

The Henry Art Gallery seeks an individual with an interest in teen programs and arts education to work as the Public and Youth Programs Assistant (PYPA). Working closely with the Associate Curator of Public and Youth Programs, Public and Youth Programs Manager, and Teen Collective Artist Facilitator, the PYPA will support the week-to-week curriculum development, coordination, and facilitation of the Henry Teen Art Collective. General support for public and youth programs will occur as needed. Tasks include, but are not limited to communicating with youth, guardians, and community stakeholders; program evaluation and assessment; participating in professional development; and project management of the activities of the Collective. The PYPA is responsible for interacting in a timely, organized, and professional manner and is an important part of shaping a growing and successful youth program. The Henry Teen Art Collective meets weekly on Thursday evenings from 4:30–6:30pm. We anticipate that the 21-22 academic year will feature a hybrid of both onsite and remote sessions, to be determined collectively. The PYPA will be expected to co-facilitate most weekly sessions.
