## **CAMP Scholar Participation Agreement**

The purpose of the College Assistance Migrant Program (CAMP) is to provide you with the necessary tools and resources to maximize your academic success within an institution of higher education. The program has two essential goals: 1) help you persist through your first year of college and 2) help you identify the appropriate resources and connect you with key faculty and staff on campus to help you graduate with a baccalaureate degree. The program provides stipends, activities, and events to prepare CAMP Scholars to succeed in their chosen academic endeavors. In return, we ask that you participate fully in these activities and adhere to the guidelines and requirements described below. Please understand that if you do not follow these requirements, securing funding for CAMP and supporting future students will be difficult. Please read this information carefully. This agreement will be reviewed and signed during the CAMP Summer Orientation Program.

## Program Activities

As a CAMP Scholar, you will be expected to fully participate in all program activities designed to enrich your academic experience and prepare you for the challenges of university life during your sophomore, junior, and senior years.

You will be required to:

- Abide by the University Student Conduct Code. As such, we encourage you to make good choices as a UW student.
- Agree to allow CAMP staff to contact you after you graduate from UW to determine your career pathway (e.g., graduate school, employment, Peace Corps, etc.).
- Apply for financial aid each year you are enrolled at UW. Please seek the guidance of CAMP staff in filling out your FAFSA each year.
- Attend CAMP cultural events and enrichment activities (those that are mandatory). Dates for these events will be circulated in advance.
- Attend all required CAMP orientations and meetings.
- Attend all scheduled CAMP workshops and activities unless you receive prior permission from CAMP staff to be absent.
- Attend and participate in the CAMP course during Autumn, Winter, and Spring quarters. Registration information will be available in advance.
- Cooperate with follow-up surveys after completing the CAMP Program.
- Maintain a GPA of at least 2.5. If you fall below a 2.5 GPA, you must work with your CAMP Advisor on an academic improvement plan.
- Meet with your CAMP Advisor at least twice a quarter for your first year (Quarterly Check-in and Pre-Registration).
- Complete and turn in Academic Progress Forms for your courses each quarter of your first year.
- Notify CAMP staff of any scholarship acceptances or rejections.
- Complete 40 study hours each quarter.
- Promptly respond to all CAMP program communications.
- Seek your CAMP Advisor for advice about registration, major selection, and experiential learning opportunities.
- After completing the first year of involvement with the CAMP program, participants must affiliate with the EOP or TRIO Student Support Services (SSS) Program to continue receiving advising and support services.

- Work with CAMP staff on resume building and internship selection.
- Work with CAMP staff on scholarship applications.
- You must maintain full-time status while participating in the CAMP (enrolled for a minimum of 12) credits per quarter). Always consult with your CAMP Advisor before changing your schedule.

## **Permission Agreements**

I understand and agree that any failure to fulfill the requirements outlined above will result in the following disciplinary measures:

- 1. A meeting will be held between the CAMP staff.
- 2. I will be placed on probationary status. A contract, written and signed by the CAMP staff and I, will outline my performance requirements for the remainder of the quarter or the upcoming quarters.
- 3. I will be dismissed from the program if I do not adhere to this contract. This will result in the immediate termination of my stipend and future CAMP courses.
