Students are encouraged to apply by submitting the following REQUIRED materials as indicated:

- printing, then completing this sheet and returning it along with word-processing generated answers to the questions on page two. (**NO** handwritten answers for Sections I-III will be accepted. Limit each answer to one page, double-spaced.)
- a current academic transcript (official or unofficial)
- Students must also have applied for financial aid at the University of Washington by filing the Free Application for Federal Student Aid (FAFSA). The FAFSA can still be completed, but four to six weeks processing time must be allowed. The FAFSA can be obtained from the Office of Student Financial Aid, 105 Schmitz Hall. Filing your FAFSA online at <http://fafsa.ed.gov> will reduce processing time by about two weeks. International students may apply and should file the FAFSA for purposes of this scholarship.
