- Original stakeholder group
- Continuing role of Puyallup Area Aging in Community Committee (PAICC)



Puyallup's Efforts

- Installed Rectangular Rapid Flash Beacons (RRFB) (stemming from crossing flag recommendation of Senior Advisory Committee)
- Considering non-motorized transportation and ADA transition plans
- Makes commitment to make the city a better place to live for residents of all ages

- Application to become an AARP/WHO Age-Friendly City March 2016
- Designation granted March 2016 -- presented May 14, 2016
- Puyallup becomes member of AARP Network of Age-Friendly Communities
- PAICC will facilitate the accountability process
- New stakeholder group formed May-June 2016
