


Panel 8 Speaker Bios

Donald Downing



Don is a Clinical Professor at the University Of Washington School Of Pharmacy in Seattle and Endowed Chair of the Institute for Innovative Pharmacy Practice. He and colleagues developed the country's first pharmacist-initiated contraception, emergency contraception and immunization programs. In January 2012 the Journal of Contraception published Prof. Downing's editorial titled: "Inviting the Pharmacist: A Model for Improved Reproductive Care Access." In 2015 Governor Inslee signed a bill written by Professor Downing, SB 5557, which requires all commercial health plans in the state to enroll pharmacists as clinical providers in their health plans...a development that promises improved access to reproductive health services.

Lisa Stone



Lisa M. Stone has been Executive Director of Legal Voice, a non-profit public interest law organization that advances legal rights for women, since 1995. Prior to obtaining her current leadership position, Ms. Stone was a volunteer attorney with Legal Voice for a number of years, serving as cooperating counsel and on various committees. In addition to her experience litigating on behalf of women patients and reproductive health care providers, she has worked in the areas of civil rights, sex discrimination and non-profit legal issues.

Ms. Stone represents Legal Voice and the legal needs of women and LGBT persons in numerous ways, including by serving on the Governance Board of Washington United for Marriage, which ran a successful referendum campaign to retain the marriage equality law passed by the Washington Legislature in 2012; on the Board of the Women's Bioethics Project; as a founding Board member of the Prescription Drug Assistance Foundation; and on the Board of Provide (formerly the Abortion Access Project).

Before taking on leadership of Legal Voice Ms. Stone worked as an environmental manager for a national oil spill cleanup company; and was an attorney for the U.S. Environmental Protection Agency Region X, and in private practice.

Gabriela Flores Rodríguez



Gabriela Flores Rodríguez was selected to be a GOJoven Fellow when she was 22 and was part of the Adolescent Sexual and Reproductive Health Initiative – AIR in 2009. She has served as Technical Secretariat for the Latin American and Caribbean Youth Network for Sexual and Reproductive Rights (REDLAC), where she took charge of the network’s communication strategy and IT management. Additionally, she founded the Young Women’s Association “Being a woman” (Ser Mujer) in Honduras. She has served on the Board of Directors of the Central American Women’s Fund (FCAM) and has worked as an advisor to the Secretary of Education where she developed an information system for the educational system. Gabriela is a lesbian feminist who participates in many forms of political advocacy, training, research and promotion of Women’s Human Rights and LGBT Rights.
