MANUFACTURER AGREEMENT

<p>1. We acknowledge that the University of Washington (hereinafter called the "University"), is the owner of all rights, titles, and interests in and to certain designations comprising designs, trademarks and servicemarks, logotypes, seals, and certain logographics and/or symbols that have come to be associated with the University of Washington (hereinafter called "licensed marks"). We agree that we will only use the licensed marks as described above, and will not use the licensed marks in any other manner without written consent by the University of Washington Trademarks & Licensing Office. Nothing in this agreement shall give us any right, title or interest in any licensed marks, except the right to use them in accordance with this agreement and as described above. We will not challenge the rights of the University to own its licensed marks, nor attempt to procure any trademark registration with respect to the licensed marks.</p> <p>2. We guarantee that the licensed articles shall be of high quality and the graphic design acceptable to the University. Before the sale or distribution of any of the licensed articles, we shall furnish to the University of Washington Trademarks & Licensing Office, free of cost, for approval, a representative sample of each item, together with any associated carton or container, packing or wrapping material containing the licensed marks. University of Washington Trademarks & Licenisng Office then has five working days from receipt thereof to accept the sample(s).</p> <p>3. Licensee agrees to indemnify, defend, and hold harmless the University, its officers, employees, servants, and agents from any claims, suits, causes of action, costs, damage, or expense of whatsoever nature arising out of or in any way connected with the production, manufacture, sale, or subsequent use of licensed items, or with workmanship, material, or design of any item manufactured or sold pursuant to this agreement, or the use of any indicia pursuant to this agreement.</p> <p>4. We agree that in the exercise of this license, we will neither state nor imply, whether directly or indirectly, that either our company, or its activities other than pursuant to exercise of the license herein, are supported, endorsed, or sponsored by the University, and, upon the direction of the University, shall issue express disclaimers to that effect. Nothing herein shall be construed to constitute the parties as joint venturers nor shall any similar relationship be deemed to exist between them.</p> <p>5.
