





Licensed Practical Nurses (LPNs)








LPN Age and Gender

Data Sources:

Washington State LPN data are from the Washington State Department of Health, Health Professions Licensing Data System, 2014 (April), 2013 (April), 2011 (March), 2008 (September), 2007 (October), 2006 (September), and 1999. General Washington population data are from the Washington State Office of Financial Management and are updated April 1 of each year (http://www.ofm.wa.gov/pop/april1/). The urban-rural location of each LPN was determined using their license ZIP code and the Rural-Urban Commuting Area Codes 2.0. All analyses include LPNs ages 18 through 75.
