Project Objectives?

- To provide common definitions for cadastral information found in public records, which will facilitate the effective use, understanding, and automation of land records; and
- To provide consistent attribute definitions and domains to enhance data sharing and cross-county utility; and
- To provide a standard for the definition and structure of cadastral data products that facilitates data sharing and protects and enhances the investments in cadastral data at all levels of government and in the private sector; and

Project Objectives?

- To develop a data sharing agreement that protects the rights of data providers while facilitating data sharing among end users; and
- To develop data access and distribution protocols that are appropriate for the entity utilizing the data product;
- To define a methodology for managing historical cadastral data products; and
- To develop a conceptual model for updating and publishing cadastral data products over time; and
- To identify parcel data production needs and enhance capability and infrastructure across the state.

- Three components of Parcel GIS
 - Production
 - Publication
 - Consumption



- FGDC/ESRI focus on production
- Data publication standard is current need which over time may evolve into a data transfer standard
