REPUBLICANS MAKE GRANT CHAIRMAN

Party Holds Love Feast Railroading All of New Executive's Wishes.

George A. Grant yesterday afternoon was elected chairman of the King County Republican committee and given authority to name an executive committee of twenty-five city members, six country men from the South and six from the North commissioner districts, a total of thirty-seven. M. S. Wooter, who, was Grant's choice for secretary, was elected to fill that office, and Henry Odom was chosen treasurer. A. Reeves Aylmore, Jr., who had been mentioned as a possible candidate for chairman, was elected vice chairman by a vote of 78 to 62 over W. W. McGuire, who was sprung at the last minute for the office.

While the new state committeeman from King County is a pronounced Frogressive, the Republican committee organization really stands for the policy of doing as little politics as possible during the war period. Grant succeeded to the chairmanship of the county committee when a war appointment made a vacancy and he did not wish to hold the job any longer. Grant is chief deputy county clerk and probably will be a candidate for the Republican clerkship nomination in 1920. He did not wish to have the county chairman's job hanging about his neck when he started in his prospective cam-

man's job hanging about his neck when he started in his prospective cam-paign, and, being a draft board office in his own district, did not believe he could find time to look after a political

could find time to look after a political campaign.

The demand for Grant's election came from county nominees and was supplemented by an insistence from leaders in all Republican factions who wished to keep factional matters in the background for the present. He is a sort of "let well-enough-alone" chairman who is not affiliated with any faction and who is likely to sit on the lid and wait until the war ends to shape up party policies.

Chairman Grant protested against being given authority to name the executive committee, claiming that precedent dictated that each ward or group of precincts should elect its own representatives. But T.D. Rockwell, nominated for state senator in the Thirty-fourth district, insisted that as Grant had been the unanimous choice of the committee for chairman he could be trusted to pick out an executive committee. It finally was decided on permit him to name a committee of thirty-seven Originally the Rockwell program contemplated an executive committee of twenty-five, but Dr. B.E. done. Several years ago demand was general for a constitutional convention and one after another the parties went on record in favor of such a meeting. The legislature of 1917 submitted the question of calling a convention to the voters and then went about its other business.

The people, therefore, must decide at the November election whether they want a constitutional convention.

Politicians say the war has brought about a changed attitude toward hold-Foliticians say the war has brought about a changed attitude toward holding a constitutional convention. Party members believe war conditions make it impracticable to write fundamental law now; that when the war is ended conditions may be so different from anything heretofore known that a consituation drafted now would be entirely out of place. The sentiment has been summed up by the declaration that during the war period everybody will do whatever is necessary and later on political principles will be adopted to meet whatever the new conditions may be.

There is no organized effort to force through the constitutional convention fight, but though the movement has no warm supporters it will be submitted on the ballot this fall and is expected to have some support because of the opposition to the present constitution that has been gathering strength for several years.

Aside from the proposal for a constitutional convention, voters will have to pass on the wet or dry issue again this fall. This fight comes up on the referendum of the so-called bone-dry law. It generally is believed the state will vote dry without making any fuss about it and politicians feel that this is to be the outcome so strongly that virtually every legislative nominee is pledged to vote for national prohibition.

Interesting comparisons between the French and American stores is made by Miss Louise Jane Beraud in a letter written to her father, Gustav Beraud, maitre de hotel of the Bender. Miss Beraud is a member of the telephone unit of the United States Signal Corps in Paris.

In speaking of he stores and goods which are most plentiful and cheap in France, she says: "I find that handker-chiefs and hand-made underwear are exceedingly cheap, also silk goods by the yard. Stockings are expensive, and ready-made clothes are neither very good looking or very cheap. Cloves, of course, are very cheap. The arrangement of the goods in the stores is very illogical, compared to our system in the United States. By that I mean that hardware may be right next to the blouse sections.

"The finances are managed like those in a small store, that is, a bookkeeper writes down at the moment the amount of each sale and the clerk hunts around for paper in which to wrap the package. The sales people are all courteous, but do not race up to a customer asking, do you need attention; or some such the clerk."

SHIPYARD WORKERS TO BE BACK ON JOB

President Wilson's Announcement Concerning Wages to Affect Local Yards.

Announcement in press dispatches from the national capital last night that President Woodrow Wilson is soon to pass upon a program for a sweeping change in the government's war wage revision poticy may have an important bearing upon the unrest among Seattle shippard workers that resulted in more than eighteen thousand of them laying down their tools as a demonstration for the forty-four hour week.

Dissatisfaction with the prolonged delay of the government's shippard wage adjustment committee in handing down a decision on demands submitted by the Pacific Coast shippard unions last July for a revision of the Coast-wide wage sale fixed by the wage salisatment committee more than a year ago, admittedly was behind the forty-four hour week demonstration, and a folegram from V. Everit Macy, chairman of the adjustment committee, declaring that President Wilson himself had asked that the decision be held back in furtherance, of a pending plan for a general readjustment of war labor wage scales, came too late apparently to block the demonstration.

The Washington, D. C., dispatches printed by The Times today, however, place the President's position clearly before the war workers, and in all probability, it is expected, will have an important bearing on the future attitude of the Seattle shipyard unions.

This was admitted by members of the Seattle Metal Trades Council, the central body of the shipyard unions, to whom the substance of the press dispatches was given last night. They refused, however, to discuss the subject pending the regular meeting of the council, to be held next Tuesday night.

In all probability the government's plan will be reported on at that meeting, and possibly action will be taken that will tend to clarify the situation.

In any event, the more than 18,000 workers who laid down their tools at noon yesterday and took a half heliday will be back on the jeb again tomorrow, but their return to work will not spell a waiver of their demands. President's Position Made Clear.

Up to Government.

Union officials said last evening that the next move must be made by the government and that unless the national shipbuilding labor adjustment committee, otherwise known as the Macy Board, handed down a decision on pending demands for revision of the expiring working agreements before that time, another lay-off would be taken next Saturday, yesterday, the union officials admitted, was primarily intended as a protest against the dealy of the Macy Board in handing down its long-expected wage revision decision.

Shipward employers had little to say regarding the demonstration. Like the union officials, they seemed to expect the next move from the government—and up to late last evening no word had come from Washington, D. C. In spite of the large number of men involved, yesterday's demonstration was marked by no disorder, the workmen having left the various plants in exactly the same manner as if the summer half-holiday rule was still in force.

REPORT ON WAGE SCALE

WASHINGTON, Saturday, Sept. 21.—
Within a short time President Wilson will have before him a report outlining a proper system of wages for the various trades and employments. The report will be the result of exhaustive study by the War Labor Policies Board, of which Felix Frankfurter is chairman, assisted by the Wage Adjustment Board of the Shipping Board, the National War Labor Board, the Labor Department, the wage divisions of the Fuel Administration and of the Railroad Administration and all other governmental agencies having to do with wages and employments.

Frankfurter started his committee's work with a study of wages as they existed previous to the war. He set up standards of wages as they were or should have been then in each employment and in the various parts of the country. With these he set up figures on the cost of living.

Set Up Proper Scale.

These tables showed the relation of wages in each industry to other industries over a period of normal years. With these preferentials which had been set up in wages between industries over a period of normal years. With these preferentials or differentials established as between employments and as between sections of the country, his committee has been able by obtaining careful figures on the country, his committee has been able by obtaining careful figures on the increase in the cost of living, to set up a standard of wages for today which more nearly represent the proper scale than those now being paid.

Ulaims of the Shipping Board that they must have preferences in wages over other businesses employing the same classes of artisans, so that construction of ships would be stimulated, have been considered. Claims of the Fuel Administration for preferences to attract miners have likewise been taken up. So also have claims of munitions plants.
