THE UNDERSIGNED H. C. PIGOTT AND JULIET T. PIGOTT, HIS WIFE

AS THE OWNERS OF THE NORTH 339.34 FEET OF THE SOUTH 612.74 FEET OF THE

GOVERNMENT LOT 3, SECTION 2, TOWNSHIP 23 NR & E, WM, LYING E.AT OF MARINE

VIEW DRIVE, EXCEPTING THEREFROM 44TH AVE. SW AND THE NORTH 60° OF THAT

PORTION LYING BETWEEN MARINE VIEW DRIVE AND 44TH AVE. SW., IN KING COUNTY

KNOWN AS H. C. PIGOTT'S ADDITION PLAT OF WHICH IS TELEWISE IN THE OFFICE

OF THE COUNTY AUDITOR OF KING COUNTY, WASHINGTON IN THE OFFICE

DO HEREBY ESTABLISH THE FOLLOWING PROTECTIVE COVENANTS TO

BUN WITH SAID LAND AS HEREIN SET FORTH.

- 1. ALL LOTS IN THE TRACT SHALL BE KNOWN AND DESCRIBED AS RESIDENTIAL LOTS.
- 2. NO STRUCTURES SHALL BE ERECTED, ALTERED, PLACED, OR PERMITTED TO REMAIN ON ANY RESIDENTIAL BUILDING PLOT OTHER THAN ONE DETACHED SINGLE-FAMILY DWELLING NOT TO EXCEED TWO STORIES IN HEIGHT AND A PRIVATE GARAGE FOR NOT MORE THAN TWO CARS.
- 3. NO BUILDING SHALL BE LOCATED ON ANY RESIDENTIAL BUILDING PLOT NEARER THAN 20 FEET TO THE FRONT LOT LINE, NOR NEARER THAN 10 FEET TO ANY SIDE STREET LINE. NO BUILDING, EXCEPT A GARAGE OR OTHER OUTBUILDING LOCATED 60 FEET OR MORE FROM THE FRONT LOT LINE, SHALL BE LOCATED NEARER THAN FIVE FEET TO ANY SIDE LOT LINE.
- 4. NO RESIDENCE OR ATTACHED APPURTENANCE SHALL BE ERECTED ON ANY LOT FARTHER THAN 30 FEET FROM THE FRONT LOT LINE.
- 5. NO RESIDENTIAL STRUCTURE SHALL BE ERECTED OR PLACED ON ANY BUILDING PLOT, WHICH PLOT HAS AN AREA OF LESS THAN 6000 SQUARE FRET.
- 6. NO NOXIOUS OR OFFENSIVE TRADE OR ACTIVITY SHALL BE CARRIED ON UPON ANY LOT NOR SHALL ANYTHING BE DONE THEREON WHICH MAY BE OR BECOME AN ANNOYANCE OR MUISANCE TO THE NEIGHBORHOOD.

T. NO PERSONS OF ANY RACE OTHER THAN THE WHITE OR CAUCASIAN RACE SHALL USE OR OCCUPY ANY BUILDING OR ANY LOT, EXCEPT THAT THIS COVENANT SHALL NOT PREVENT OCCUPANCE BY DOMESTIC CARVANTS OF A DIFFERENT RACE DOMICILED WITH AN OWNER OR TENANT.

- 8. NO TRAILER, BASEMENT, TENT, SHACK, GARAGE, BARN OR OTHER OUTBUILDING ERECTED IN THE TRACT SHALL AT ANY TIME BE USED AS A RESIDENCE TEMPORARILY OR PERMANENTLY, NOR SHALL ANY STRUCTURE OF A TEMPORARY CHARACTER BE USED AS A RESIDENCE.
- 9. NO DMELLING COSTING LESS THAN \$2000. SHALL BE PERMITTED ON ANY LOT IN THE TRACT. THE GROUND FLOOR AREA OF THE MAIN STRUCTURE, EXCLUSIVE OF ONE-STORY OPEN PORCHESAND GARAGES, SHALL BE NOT LESS THAN SIX HUNDRED SULARE FEET IN THE CASE OF A ONE-STORY STRUCTURE NOR LESS THAN FIVE HUNDRED AND FIFTY SQUARE FEET IN THE CASE OF A ONE AND ONE-HALF, TWO OR TWO AND ONE-HALF STORY STRUCTURE.
- 10. THAT ANY DESCLING OR STRUCTURE ERECTED OF PLACED ON ANY LOT IN THIS SUBDIVISION SHALL BE COMPLETED AS TO EXTERNAL APPEARANCE INCLUDING FIVISHED PAINTING WITHIN 8 MONTHS FROM DATE OF COMMENCEMENT OF CONSTRUCTION AND SHALL BE CONSCIEND TO SEPTIC TANK OR PUBLIC SEWER ADE.
- 11. THESE COVENANTS ARE TO HUN WITH THE LAND AND SHALL BE BINDING ON ALL THE PARTIES AND ALL PERSONS CLAIMING UNDER THEM UNTIL JANUARY 1, 1966, AT WHICH TIME SAID COVENANTS STALL BE AUTOM ATICALLY EXTENDED FOR SUCCESSIVE PERIODS OF THE YEARS UNLESS BY A WOTE OF THE MAJORITY OF THE THEM OWNERS OF THE LOTS IT IS AGREED TO CHANGE THE SAID COVENANTS IN WHOLE OR IN PART.

IF THE PARTIES HERETO, OR ANY OF THEM, OR THEIR HEIRS OR ASSIGNS, SHALL VIOLATE OR ATTEMPT TO VIOLATE ANY OF THE COVENANTS HEREIN IT SHALL BE LAWFUL FOR ANY OTHER PERSON OR PERSONS OWNING ANY REAL PROPERTY SITUATED IN SAID DEVELOPMENT OR SUBDIVISION TO PROSECUTE ANY PROCEEDINGS AT LAW OR IN EQUITY AGAINST THE PERSON OR PERSONS VIOLATING OR ATTEMPTING TO VIOLATE ANY SUCH COVENANT AND RITHER TO PREVENT HIM OR THEM FROM SO DOING OR TO RECOVER DANAGES OR OTHER DUES FOR SUCH VIOLATION.

INVALIDATION OF ANY ONE OF THESE COVENANTS BY JUDGMENT OR COURT ORDER SHALL IN NO WISE AFFECT ANY OF THE OTHER PROVISIONS WHICH SHALL REMAIN IN FULL FORCE AND EFFECT.


