


# RIDGECREST HOMES

## DESCRIPTION

This plat of RIDGECREST HOMES embraces all of the Northeast Quarter of the Southwest Quarter of Section 8, Township 26 North, Range 4 East, W.M. All courses and distances are shown hereon.

## RESTRICTIONS

No lot, or portion of a lot, in this plat, shall be divided and sold or resold, or ownership changed or transferred, whereby the ownership of any portion of this plat shall be less than the area required, for the Use District stated on this plat; namely, six thousand (6000) square feet for R-1 Residence Use, with a minimum lot or tract width of sixty (60) feet.

All lots in this plat are restricted to R-1 District Use, except no lot, or portion of a lot, shall be sold, to, leased to or occupied by, any person other than that of the White or Caucasian Race, except this shall not prevent occupancy by domestic servants of a different race or nationality, actually employed in good faith by the owners or tenants, governed by and subject to restrictions, rules and regulations of County Zoning Resolution No. 6494 and subsequent changes thereto by official County resolution.

## DEDICATION

KNOW ALL MEN BY THESE PRESENTS that we, the undersigned, ALBERT L. LA PIERRE and AIDA LA PIERRE, husband and wife, and ALLAN MAC LEAN and NELLIE MAC LEAN, husband and wife, and HOWE S.
