This conveyance is made expressly subject to and under the following restriction and condition, to wit: (a) No part of said property shall ever be used or occupied by any person of the Ethiption, Malay, or any Asiatic race, and the grantee, his heirs, personal representatives or assigns, shell never place any such person in the possession or occupancy of said property, or any part thereof, nor permit the said property, or any part thereof, nor occupied by any such person excepting only employes in the domestic service on the premises of persons qualified hereunder as occupants and users and residing on the premises.
