This deed is given subject to the following restrictions:

These restrictions shall run with the land and shall be bind-

ing on the parties thereto, their heirs and assigns, but may be modified or waived after ten years from May 1, 1925, by written agreement, acknowledged and recorded of two thirds of the owners at the time of Tracts 30 to 47 inclusive.
