DEED

THE GRANTORS, Franklin S. Williams and Mary D. Williams, his wife, for and in consideration of the sum of ten dollars (\$10.) and other good and valuable consideration to them in hand paid, receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell, convey and confirm unto H. P. M. Luther, grantee, of Seattle, Washington, the following described real estate in Seattle, King County, Washington:

Lot Three (3) of Williams Alki Addition to Seattle, according to the official plat on file and of record in the office of the County Auditor of King County, Washington.

TO HAVE AND TO HOLD the said property unto the said grantee, his heirs and assigns forever, subject, however, to all taxes and assessments and liens and encumbrances which may have accrued again said property, by, through or under the grantee since the signing of the agreement of sale heretofore entered into between the grantors and the grantee, and subject to a certain declaration of restriction affecting all of the lots in Williams' Alki Addition to the City of Seattle, which declaration has been heretofore filed by the grantors. The restrictions herein set forth run with the land and shall be of full force and effect until January 1st, 1940.
