WARRANTY DEED

Mary Isabel Ives

The Grantor, WOODWAY PARK CORPORATION, a corporation of Seattle, Washington, for and in consideration of the sum of Ten Dollars (\$10.00) Dollars, and other valuable consideration, in hand paid, conveys and warrants to Mary Isabel Ives, of Seattle, Washington, the following described real estate situate in Snohomish County, State of Washington, to-wit:

Beginning at a point on the east and west center line of Section 35, Township 27 North, Range 3 East, W.M., distant North 89° 15' 28" West, 1351.79 feet from the East one-quarter Section corner of said section, said point being marked by a stone monument on the West margin of Templeton Road; and running thence along said West margin and its northerly production North 0° 55' 02" West, 894.12 feet; thence along a curve to the right of radius 654.59 feet, a distance of 207.84 feet; thence North 17° 16' 30" East, 105.36 feet to a point on the South line of Tract 7, Woodway Park (unrecorded), being the true place of beginning of this description, and running thence North 89° 15' 28" West, 727.52 feet to the northeasterly margin of Woodway Park Road as established by the Engineer of Snohomish County by Survey 1202; thence along the said road margin South 10° 30' 00" East, 216.15 feet; thence South 89° 15' 28" East, 632.72 feet to the arc of the curve of radius 654.59 feet, as above mentioned; thence northerly along the said arc, (radius at this point bears South 82° 36' 35" East 654.59 feet to center) a distance of 113.31 feet; thence North 17° 16' 30" East, 105.36 feet to the true place of beginning, containing 3.32 acres, more or less, being Tract 8A, Woodway Park (Unrecorded); Subject, however, to the following covenants, conditions, restrictions and limitations:

a. The said property shall be used by the Grantee, his heirs, executors, administrators and assigns, for residence purposes only during the period of fifty (50) years from July 1,1920.

b. The Grantee shall not during said period of fifty years subdivide said tract, nor shall more than one residence (other than servants' quarters and necessary outbuildings) be erected on each two acres of said tract during said period of fifty years.

c. No building of any kind shall be constructed on said tract within one hundred (100) feet of the road without the written approval of the Grantor nor within fifty (50) feet of any boundary line of said tract without the written consent of the adjoining owner.

d. Neither said premises, nor any interest therein, shall at any time be leased, sold, devised or conveyed to, or inherited by or otherwise acquired by, become the property of, be used or occupied by any person other than one of the white or Caucasian race, provided, however, that persons not of the white or Caucasian race may be kept thereon by such a white or Caucasian occupant strictly in the capacity of servants of such occupant.

e. The foregoing covenants, conditions, restrictions, and limitations are and shall be, and are hereby made covenants running with the land, and a breach of any of them may be enjoined, abated or remedied by the appropriate proceedings maintained by any owner in said Woodway Park or their successors in interest.

f Until a plat of Woodway Park is filed in the office of the Auditor of Snohomish County, the term "Woodway Park" as used herein shall be taken and understood to include that part of Sections twenty-six (26) and thirty-five (35), Township twenty-seven (27) North, Range three (3) Eastlying South of the center line of said Section twenty-six (26) and North of the center line of said Section thirty-five (35), the chain of title to which shall have passed through Woodway Park Corporation.
