- 2. No building or structure other than one single, detached dwelling house, with stigle, detached aweiling tiques, with garage appurfenant thereto and in architecture in harmony therewith, shall be constructed, maintained or permitted on any building site in this plat. A building site is defined as at least one lot. as now
- platea.

 3. No dwelling house shall be erected, placed or maintained upon any lot embraced within this plat which shall cost or be of the value of less than the respective sums on respective parts thereof, as follows: each lot abutting Porly-Pirst Avenue West, Seven Thousand Five Hundred (1500) bollars; each lot abutting Fortieth Avenue West, Six Thousand (6.000) bollars; each lot abutting Thirty-Ninth, Thirty-Eighth, Thirty-Seventh, and Thirty-Sixth Avenues West, Five Thousand (5.000) bollars; (5.000) Dollars.
- 4 No domestic fowl nor animals, other than dogs or cals kept as household pets, ever shall at any time be kept or allowed upon any land embraced in this plat.
- 5 No person other than one of the White race shall be permitted to occupy any portion of any lot in this plat, or dany building at any time thereon, except a domestic servant actually employed by a White occupant of such a building.
- 6 No building nor any part thereof shall be constructed or maintained on any lot in this plat nearer to the front street margin than the line designated upon said plat as "building limit".
