No barns or chicken houses, nor tar papered or corrugated iron finished buildings shall be permitted on said property. All toilets, even for temporary use, must be connected with properly installed concrete septic tank or sewer if available. No commercial buildings, advertising signs or billboards shall be permitted on the premises. No building shall be erected within 20 feet from the Malloy road boundary. Any violation of said covenants, or any of them, may be restrained by injunction in any court of competent jurisdiction by any owner of any part of Memorial Heights.
