reproductive health care and advocacy fellowship

Reproductive Health Care and Advocacy Fellowship

A year-long clinical fellowship that creates leaders who promote, provide, and teach full-spectrum reproductive health care.

There are currently four fellowship positions available: two based in New York City, one based in Boston, and one in Seattle.

All fellows will participate in the following activities:

- 1. Fellows will spend one year as a "trainer in training," learning to perform abortion and related procedures (IUD and implant insertions and removals, first-trimester sonography, medication abortion, endometrial biopsy, and manual vacuum aspiration of the uterus) and learning to teach these procedures to others. The fellow will also spend 15 to 20 days at a high-volume abortion site, getting training and becoming a trainer.
- 2. Fellows will work at a family medicine site seeing continuity care patients.
- 3. Fellows will develop teaching skills by precepting family medicine residents one session per week, learning to teach and give feedback under the supervision of the residency faculty.
- 4. Fellows will develop teaching and leadership skills by giving presentations during residency curriculum sessions and at academic family medicine meetings. The fellow will participate in advocacy projects that promote access to reproductive health care in family medicine, with guidance from the Reproductive Health Access Project. The fellow, in collaboration with residents and faculty, will work on the on-going projects with a goal of preparing presentations for academic meetings and publications for family medicine journals.
- 5. Fellows will work with local medical schools to provide reproductive health training opportunities for medical students.
- 6. Fellows will apply to the Physicians for Reproductive Health's Leadership Training Academy.

Application Process

Applications for the Reproductive Health Care and Advocacy Fellowship can only be submitted electronically. To apply, please email the following materials to fellowship@reproductiveaccess.org. Applications are accepted on a rolling basis until December 1st. Interviews are scheduled on a rolling basis upon receipt of application.

- Cover letter stating the reasons for interest and career goals
- Three references (must either be on electronic letterhead with an electronic signature or a scanned pdf of the letter on letterhead with a signature)
- Curriculum vitae

Recruitment Criteria

Applicants must be board-certified or board-eligible family physicians who will have completed residency training by August 1 of the fellowship year. Recent graduates and mid-career physicians are eligible. Candidates need not be fully trained in women's health procedures. **Candidates should have the appropriate state licenses before their start date of the fellowship.** High priority will be given to clinicians who will do one or more of the following:

- Plan to provide abortion care in an abortion provider shortage area.
- Commit to developing a new abortion-training program at a family medicine residency program that currently offers no abortion training.
- Speak openly about being an abortion provider.
