Even in its most tense or hectic moments, GPSS serves a space for dedicated students to work together in the dual spirit of representation and advocacy for our campus and fellow students. Website and Records Transformation: As most of you know, GPSS has undergone several transformations this year with regard to its internal workings such as a website overhaul that shifted our mechanisms for attendance and voting and the slow migration from Google to other platforms that is segueing into the 2023-2024 year and which has widely affected our GPSS archive and ability to work collaboratively online. If elected, I would like to continue to explore solutions to these issues, such as working towards hiring a dedicated website developer to help make our website functionality more stable and more accessible and continuing to reorganize the GPSS digital archive during the ongoing transition to a new digital platform.

Onboarding and Community-Building: In my tenure as Vice President of Administration, I have given much of my focus this year to making sure that Senators, especially new Senators, have the tools and understanding at their disposal to participate effectively an meaningfully in GPSS. Whether it was updating and distributing the Senator Handbook, explaining and supporting parliamentary procedures, providing feedback and guidance on the resolution-writing process in Senate, liaising with students one-on-one with regard to attendance requirements, keeping a regular New Senator/Open Questions working group at Senate meetings to provide space for learning, offering interpretation and support with regard to bylaws revisions and suggestions, helping Arts Council, CSMR, Elections, and the Judicial Committees with their initial startups, revitalizing the Senator of the Month program, or even simply providing Zoom, tech, and time support during our meetings, onboarding and community-building has been a top priority for me. If elected, I will continue to focus in this area to ensure Senators feel comfortable and prepared to be involved meaningfully in GPSS.

Understanding the importance of this role, I am both humbled and excited to seek re-election.
