I. Program Description

A. Short Description of Funding Opportunity

ERDC seeks applications for: a cooperative agreement to support completing the final analysis of alternatives for an Environmental Impact Statement (EIS) for the Willamette System (WS), development of tools and analysis supporting implementation and adaptive management following a Record of Decision on continued operation of the WS.

B. Background

The U.S. Army Corps of Engineers, Portland, Oregon District, drafted the Willamette Valley System (WVS) Operations and Maintenance Programmatic Environmental Impact Statement (WS DEIS) in 2022 and submitted a Biological Assessment (BA) to the U.S. Fish and Wildlife Service and National Marine Fisheries Service in 2023, in accordance with NEPA and ESA. The proposed action in the BA reflects the draft preferred alternative included in the WS DEIS. Proposed measures include both operational and structural changes to address effects on ESA-listed fish in the Willamette River Basin. Biological Opinions received from the Services are expected to include recommend changes, which will be used to develop and finalize the final EIS and a Record of Decision. The goal of this proposed cooperative agreement is to 1) complete analysis on the effects of alternatives included in preparation of a final EIS on ESA-listed salmon and steelhead, and 2) address research and adaptive planning needs stemming from the Final WS EIS and ROD.

Analysis of the effects on ESA-listed salmon and steelhead was primarily completed using the Integrated Passage Assessment model, a lifecycle model allowing effects on population abundance, productivity, distribution, and diversity in the draft EIS. The life cycle model included estimates of downstream passage survival developed from a second model account for the configuration of each dam and hydrology conditions at the dam (e.g. pool elevations, routes in operation, discharge) occurring across multi hydrologic years. For finalization of the EIS, analysis of any modified or new alternatives considered will need to use the same approach.

Once the EIS is final, and a record of decision (ROD) is signed, implementation will begin. An Implementation and Adaptive Management Plan (AM Plan) is included as part of the WS EIS. The AM Plan defines the metrics to be monitoring in the field and criteria for assessing success. The plan also defines an adaptive management process to review monitoring results with partnering agencies and stakeholders participating in the WATER forum established under the 2008 Biological Opinion, and the process for evaluating proposed changes and making decisions to implement changes where needed to achieve objectives and performance criteria. Tools are needed to evaluate proposed changes and assess the effectiveness of changes on population attributes in the face of uncertainty. These tools must be capable of dealing with a range of data types and providing information in the format and units consistent with goals and objectives decision makers are concerned with, and account for costs, uncertainties, and risks so decision makers clearly understand trade-offs among available options when managing for a range of goals and objectives. Simulation modeling provides opportunities to incorporate iterative learning by using simulated data that otherwise could only be collected by monitoring over very long timelines.

C. Program Description/Objective:

This proposed agreement proposes three key aspects to support timely implementation of the WS EIS and AM Plan: 1. Development of simulation tools that are then transferred to managing agencies for ongoing implementation, 2. Demonstrated application of simulations to inform management direction under

uncertainty 3. Incorporation of the best available data as it comes available to update the simulation modeling, leading to a more informed management decision. This will require a combination of salmon life cycle modeling, refinement and application of downstream passage modeling using the Fish Benefit Workbook developed by the Corps, and ongoing monitoring and analysis to inform these models. The proposed work includes completing analysis of effects of the preferred alternative on Upper Willamette River Spring Chinook and winter steelhead, supporting completion of the final EIS. Work proposed also includes description of an adaptive management framework wherein objectives, performance, uncertainty, risk, and value of information are explicitly quantified. This allows resource managers to 1) update testable hypotheses efficiently, 2) make use of limited data or disparate data types, 3) reduce analytical timelines, and 4) when presented with logistic or funding obstacles, can identify which monitoring data should be prioritized and collected thus remaining efficient with taxpayer dollars. The proposed work further includes refining the Corps Fish Benefit Workbook (FBW), recently converted to R, to address structural limitations identified in previous scientific reviews, and completion of FBW models delivered for future application by USACE and other parties. Similarly, proposed work includes development and delivery of lifecycle models for future application by USACE and other parties, with capabilities similar to those applied in the 2022 WS EIS.

Analysis will occur once Biological Opinions from NMFS and USFWS are received and associated recommended changes (expected in summer 2024). Analysis during summer 2024 will be supported by contracts which expire in September 2024, however analysis will continue into fall 2024 and potentially winter 2025. Once final and a record of decision is signed, implementation and adaptive management begins during the remainder of 2025 and future years.

D. Public Benefit

The WS is a multi-purpose flood control project. The WS EIS, drafted in 2022, considered public input to develop novel solutions for managing the system while balancing authorities. The proposed research supports the continued evaluation of alternative management of the system based on regional and public input. The proposed research is consistent with continued public involvement in the management of shared public resources, particularly Upper Willamette spring Chinook salmon and winter steelhead. These species in particular have commercial and recreational fishery and tribal value and have been identified as a key resource for the people of the Pacific Northwest.

This research and data collection will be used to evaluate alternatives for continued operations and maintenance of the WS and address effects of the WS on ESA-listed fish. Research and monitoring results will provide public benefit through enhanced survival of key threatened and endangered fish species in the Columbia and Willamette rivers and their tributaries.

- Government's substantial involvement includes government oversight of all aspects of the project: collaboration, hypothesis development, study design, and simulation testing. While the contractor will provide the software and modeling expertise, the government will select which adaptive management scenarios and research needs are prioritized using recommendations from regional partners and Federal Experts.

This opportunity is restricted to non-federal partners of the Pacific Northwest Cooperative Ecosystems Studies Unit (CESU).

Prior to award and throughout the period of performance, ERDC may continue to request updated continuing and pending support information, which will be reviewed and may result in discontinuation of funding.

This action will be 100% funded by USACE.

Statements will be evaluated based on the investigator's specific experience and capabilities in areas related to the study requirements.

administrative burden. The plan will provide a justification for such decisions.

V. Application Review Information

A. Selection Criteria

Applications will be evaluated using the following criteria, listed in descending order of importance:

- Technical merits of the proposed research and development; and
- Potential relationship of the proposed research and development to Department of Defense missions
- Demonstrated experience with models of salmon and steelhead lifecycles, with integrated passage at dams, as described in the 2022 draft WS EIS. This experience should include application to federal alternative management evaluations.
- Demonstrated experiences in development and application of adaptive management of public resources.

B. Review and Selection Process:

Each application will be reviewed based on the selection criteria above rather than against other applications submitted under this Announcement.

Based on the Peer or Scientific Review, proposals will be categorized as Selectable or Not Selectable (see definitions below). The selection of the source for award will be based on the Peer or Scientific Review, as well as importance to agency programs and funding availability.

i. Selectable: Proposals are recommended for acceptance if sufficient funding is available.

ii. Not Selectable: Even if sufficient funding existed, the proposal should not be funded.

Note: The Government reserves the right to award some, all, or none of proposals. When the Government elects to award only a part of a proposal, the selected part may be categorized as Selectable, though the proposal as a whole may not merit such a categorization.
