
#### Linda Egnatz, Global Seal of Biliteracy

Linda L. Egnatz has served the Global Seal of Biliteracy as its Executive Director since its foundation in 2018. She is an educator emeritus of the Lincoln-Way Community High School District #210 in Illinois, where she taught all levels of Spanish including both AP Spanish Language & Culture and AP Spanish Literature & Culture. Egnatz is President-Elect of the Joint National Committee for Languages--National Council for Languages and International Studies (JNCL-NCLIS) and the Illinois Council on the Teaching of Foreign Languages (ICTFL) of which she was President (2013-14). She has taught as an Adjunct at DePaul University, Purdue University and Joliet Junior College. Egnatz is the recipient of multiple awards including being named the 2014 ACTFL National Language Teacher of the Year. Egnatz is a popular keynote speaker and consultant in the areas of language proficiency and regularly provides professional development offerings for language educators internationally.

### Veronica Trapani, Ed.D., Washington State Office of Superintendent of Public Instruction



Dr. Veronica Trapani joined OSPI as the Associate Director for Content, World Languages and International Education in 2020 after a decade of teaching German and English in Michigan, Tennessee, New York, and Germany. In 2021, she successfully completed her Ed.D. through Vanderbilt University, focusing on the social and emotional well-being of international students.

Veronica was recently elected to the Board of the National Council of State Supervisors for Language (NCSSFL) as Technology Supervisor. She is also currently working with ACTFL to collect data to support National Bord Certification for All Languages. Veronica's interests, outside language acquisition and education, include cats, soccer, hiking, skiing, and musical theater.

# Michele Anciaux Aoki, Ph.D., Consultant to UW STARTALK and GenCyber Grants



Dr. Michele Anciaux Aoki is an International Education and World Languages Advocate. She previously served as World Languages Program Supervisor at the Washington State Office of Superintendent of Public Instruction, developing the World Languages Competency-Based Credit Program that lay the foundation for the State Seal of Biliteracy. Michele also served as International Education Administrator for Seattle Public Schools, responsible for ten International Schools with Dual Language Immersion Programs in Spanish, Japanese, and Mandarin. Michele has served as Program Director and consultant to the University of Washington STARTALK Russian and Portuguese Heritage Language programs since 2011 and coordinated the annual Heritage Language Symposium. In 2020-2021, she developed and managed an innovative state Heritage Language grant for Romanian, Russian, and Spanish Heritage language students to earn the Global Competence Certificate and Global Seal of Biliteracy.

Currently, Michele volunteers with the Washington Association for Language Teaching (WAFLT) Testing Team and serves as Advocacy Chair for the National Council of State Supervisors for Language (NCSSFL) and on the Advisory Board of the Global Seal of Biliteracy. Michele has a Ph.D. in Slavic Linguistics from the University of Washington. She has received leadership awards from the Washington Association for Language Teaching (WAFLT) and Pacific NW Council for Languages (PNCFL), the Consul General Award from the Consul General of Japan, and most recently, the J. - Complete World Language Competency-Based Credit testing to earn the Global Seal of Biliteracy.



#### The Global Seal of Biliteracy



The Global Seal of Biliteracy provides a consistent, inclusive and accessible solution that expands a language credential to bilinguals worldwide of any age. https://theglobalseal.com/the-global-seal.

To aualify. students tested both in their Heritage Language (Romanian, Russian, or Spanish) and English for two levels:

- Functional Fluency medal: Overall Intermediate Mid level proficiency
- Working Fluency medal: Overall Advanced Low level
  proficiency

Notes:

- 3 Russian students and 1 Spanish student who qualified for the WA State Seal of Biliteracy did not complete English testing to qualify for the Global Seal of Biliteracy.
- Due to COVID-19, tests had to be proctored remotely; that was a barrier for some students to complete the tests by the end of June 2021.
- For the State Seal of Biliteracy, students do not actually "Earn" the Seal until high school graduation.

Language	# State Seal of Biliteracy "Proficient"	Would have qualified for: # Global Seal of Biliteracy Functional Fluency	Would have qualified for: # Global Seal of Biliteracy Working Fluency
Russian	18	7	11

#### Notes:

- 19 students tested using ACTFL OPIc and WPT for Russian (after taking AAPPL for pre-test).
- For the State Seal of Biliteracy, students do not actually "Earn" the Seal until high school graduation.
- The UW STARTALK Program did not submit the students' test results for the Global Seal this year.
