Parking Sign Up Steps and Regulations:

1. First contact Parking Services at ext. 57385 for information on parking availability.
2. Sign up on WageWorks before the 10th of the month to begin parking on the 1st of the next month. Ex: Before Jan 10 for a Feb 1 start.
3. Parking Services will confirm authorization of parking choice.
4. Parking Services will provide parking permit, keycard, remote, and directions for parking location.
5. Cancellation must be done in WageWorks before 10th of the month to end by 1st of the next month. Ex: Before Jan 10 to stop on Feb 1.
6. Parking cannot be prorated for any month. Partial month parkers must pay full rates per IRS guidelines.
7. Garage Clearances and stall sizes vary. Please inquire for details.
