TRANSHEALTH BENEFIT OVERVIEW

My name is Cathy, and I am part of the transhealth care team for Washington Apple Health (Medicaid) enrolled clients. I would like to offer you this overview of the transhealth benefit through Apple Health. This is general information that may answer your questions. Please read it over and email me if you have any additional questions or concerns at transhealth@hca.wa.gov.

<u>HORMONE THERAPY and MENTAL HEALTH SERVICES</u>: Hormone therapy and mental health services are covered services. If you are covered by one of our managed health care organizations (MCO) such as Molina, United Health Care, Amerigroup, Coordinated Care or Community Health Plan of Washington, these services are paid for by them. Contact your managed care organization to inquire about providers. The telephone number is on the back of your insurance card.

<u>GENDER AFFIRMING TREATMENT</u>: Other procedures, mostly surgical will be covered by Fee for Service which you may know as Provider One (your teal-colored card). These services may have specific criteria and may require prior authorization before receiving the service.

REQUIREMENTS: The provider of these services must be an Apple Health approved and enrolled provider. There are different requirements depending on what service you want to have performed.

- ❖ It is a general requirement that the client has been on gender affirming hormone therapy for a minimum of 12 months preceding surgery, unless otherwise noted below, or have
 - A medical contraindication to hormone therapy
- ❖ It is a general requirement that the client has lived in a gender role that is congruent with their gender identity for a minimum of 12 months preceding surgery, unless otherwise noted, or
 - Been unable to live in their desired gender identity due to personal safety concerns.

BREAST AUGMENTATION CRITERIA:

- One recent (within the past 18 months) comprehensive psychosocial evaluation from a licensed mental health care provider,
- Recent (within the past 18 months) letter from the provider managing your gender affirming hormone therapy, and
- Recent history and physical, and surgical plan from the surgeon who will perform the surgery.

MASTECTOMY CRITERIA:

- One recent (within the past 18 months) comprehensive psychosocial evaluation from a licensed mental health care provider,
- Recent (within the past 12 months) letter of medical necessity supporting the request for mastectomy from the primary care provider, and
- Recent history and physical, and surgical plan from the surgeon who will perform the surgery.
- It is a **not** a requirement that you have been on hormone therapy and/or lived in a gender role that is congruent with your gender identity for a minimum of 12 months.

HYSTERECTOMY AND ORCHIECTOMY CRITERIA:

- One recent (within the past 18 months) comprehensive psychosocial evaluation from a licensed mental health care provider,
- Recent (within the past 18 months) letter from the provider managing your hormone therapy. It is a general requirement that the client has been on gender affirming hormone therapy for a minimum of 12 months, before surgery, and

- Recent history and physical, and surgical plan from the surgeon who will perform the surgery.
- It is <u>not</u> a requirement that you have lived in a gender role that is congruent with the client's gender identity for a minimum of 12 months, preceding surgery.

FULL BOTTOM SURGERY CRITERIA:

- Two recent (within the past 18 months) comprehensive psychosocial evaluation from a licensed mental health care provider,
- Recent (within the past 18 months) letter from the provider managing your hormone therapy, and
- Recent history and physical, and surgical plan from the surgeon who will perform the surgery.

These providers offer full bottom surgery for transgender clients and are enrolled with Apple Health. The names given here are not recommendations based on care provided or provider preference.

OTHER GENDER AFFIRMING TREATMENT CRITERIA:

- One recent (within the past 18 months) comprehensive psychosocial evaluation from a licensed mental health care provider,
- Recent (within the past 18 months) letter from the provider managing your gender affirming hormone therapy, and
- Recent history and physical, and surgical plan from the surgeon who will perform the surgery.

This is not an exhaustive list of providers. You can see any surgeon that performs the surgery you are seeking if they are enrolled with Apple Health. The consultation does not require a prior authorization. To get started, call the enrolled provider you are interested in seeing and schedule a consultation. The provider will need to get a prior authorization for the surgery itself. You can also go to the ProviderOne find a provider site if you know the name of a surgeon, and want to see if they take Apple Health.

TRANSPORTATION/LODGING:

If needed, your transportation to and from appointments for covered services may be paid for. You just need to call an Apple Health contracted transportation broker in the county where you live and schedule a ride. You only need to tell the broker that you are going for a medical appointment and no other details. It is strongly recommended that you contact the transportation broker 7-14 days in advance of your healthcare appointments with a required minimum of 2 business days advance notice.
