## **TRAINING COMPONENTS:**

**Part I: November 5, 2008. 1:00 pm to 4:30 pm. Organizational Readiness Consultation.** *Appropriate for RSN contracted community mental health provider administrators, their designees and interested RSN and Indian Nations administrative representatives. Administrators will receive an overview of TF-CBT; learn about the training plan for Washington, and how their organization can best support outcomes and sustainability.*

**Part II: November 6 & 7, 2008. 8:30 am to 4:30 pm. Core Clinical Training by Shannon Dorsey and Lucy Berliner.** *For RSN contracted community mental health provider teams consisting of one children's mental health supervisor and two clinicians. Regional Children's Administration staff and contractors are also invited to attend.*

**Part III: Telephone Clinical Consultation. 2 times a month for 6 months.** *Conducted by expert consultants: TF-CBT developers and Harborview Center for Sexual Assault and Traumatic Stress. A certificate of completion will be granted to those having participated in at least 9 of 12 consultations.*

- ❖ **Program participation in all three components is required. (For example if an agency is sending a clinical team to the 2-day training, an administrator or their delegate must participate in Part I and the clinical team must participate in the consultation calls).**
- ❖ **Participants are responsible for payment of their own travel and lodging.**
- ❖ **Federal Block Grant funds are supporting the training components**

## **IF YOU WANT TO ATTEND THIS CONFERENCE:**

- **The program administrator is responsible to approve agency participation in this training. Up to 4 people per agency/program can attend the training (2 clinical staff, 1 clinical supervisor and 1 administrator).**
